## RELEASE OF SECURITY INTEREST IN TRADEMARKS

The Assignees further agree to execute any other documents and take any further action which is reasonably necessary to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Assignor's counsel and the cost and expense of such documents and actions shall be borne solely by the Assignor.

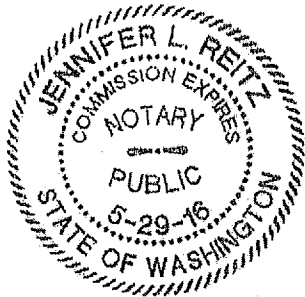
