**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated as of March 20, 2016 (this "Release"), is made by Silicon Valley Bank ("Bank"), pursuant to the Loan and Security Agreement, dated as of August 7, 2013, among Advantar Laboratories, Inc., a Delaware corporation ("Grantor").

WITNESSETH

WHEREAS, pursuant to the Loan and Security Agreement, the Grantor executed the Intellectual Property Security Agreement (the "Intellectual Property Security Agreement") and recorded with the U.S. Patent and Trademark Office on August 8, 2013 at Reel/Frame No. 5087/0487, pursuant to which the Grantor granted to the Bank for the ratable benefit of the Secured Parties a security interest in the Grantor's right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Loan Agreement);

- (a) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");
- (b) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;
- (c) Any and all rights that may be available to Grantor now or hereafter existing, created, acquired or held;
- (d) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the "Patents");
- (e) Any trademark and service mark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the "Trademarks");
- (f) All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, the "Mask Works");
- (g) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and

collect such damages for said use or infringement of the intellectual property rights identified above;

- (h) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;
- (i) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and
- (j) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank agrees as follows:

The Bank hereby TERMINATES, without recourse, representation or warranty of any kind or nature, and RELEASES, without recourse, representation or warranty of any kind or nature its security interest in the IP Collateral, including the patents, patent applications, trademark registrations, and trademark applications set forth in Exhibits A - D, attached hereto and incorporated herein by reference.

The Bank hereby GRANTS to the Grantor any additional authorization reasonably necessary to effect the release of the Bank's security interest in the Intellectual Property Collateral.
