
WHEREAS, the Assignor has satisfied the obligation secured by the Security Agreement in full.

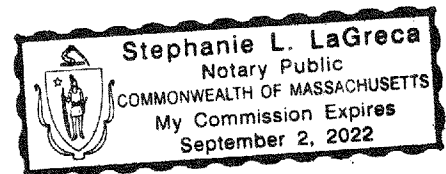
