This Certificate of Conversion of GATEWAY FUNDING DIVERSIFIED MORTGAGE SERVICES, L.P., a Delaware limited partnership (the "Partnership"), dated as of May 28, 2015, has been duly executed and is being filed by the undersigned, as the sole general partner of the Partnership and an authorized person, to convert the Partnership to FINANCE OF AMERICA MORTGAGE LLC, a Delaware limited liability company (the "Company"), pursuant to Section 17-219 of the Delaware Revised Uniform Limited Partnership Act and Section 18-214 of the Delaware Limited Liability Company Act.

3. For all purposes of the laws of the State of Delaware, the date the existence of the Company is deemed to have commenced is July 11, 1994.
4. The name of the Partnership immediately prior to the filing of this Certificate of Conversion is GATEWAY FUNDING DIVERSIFIED MORTGAGE SERVICES, L.P.
5. The name of the Company as set forth in its Certificate of Formation being filed in accordance with Section 18-214(b) of the Delaware Limited Liability Company Act is FINANCE OF AMERICA MORTGAGE LLC.
6. This Certificate of Conversion shall be effective on May 29, 2015 at 3:05 p.m.
7. The conversion has been approved in accordance with Section 17-219 of the Delaware Revised Uniform Limited Partnership Act and Section 18-214 of the Delaware Limited Liability Company Act.
