TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Assignment") is entered into as of October 6, 2014 ("Effective Date") between Frankie Valli and Bob Gaudio ("Assignors"), both individuals with an address of 2850 Ocean Park Blvd, #300, Santa Monica, California, 90405, on the one hand, and The Four Seasons, LP ("Assignee"), a California limited partnership with an address of 2850 Ocean Park Blvd, #300, Santa Monica, California, 90405, on the other hand. For purposes of this Assignment, Assignors and Assignee may be collectively referred to herein as the "Parties."

WHEREBY, on October 6, 2014, Assignors filed and established a limited partnership under the name The Four Seasons, LP in California, of which the Assignors, individually, are partners;

WHEREBY, the Assignors wish to assign, and the Assignee wishes to accept such assignment, of the rights, title and interest set forth below.

NOW THEREFORE, in consideration of the covenants, representations and warranties set forth herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the Parties agree to the following:

Assignors hereby irrevocably assign, transfer and convey to Assignee, without any restrictions, limitations or reservations, and Assignee does hereby accept the assignment, transfer and conveyance of, all of Assignors' entire worldwide rights, title and interests in and to the marks: FRANKIE VALLI; FRANKIE VALLI AND THE FOUR SEASONS; THE FOUR SEASONS and any stylizations, designs or the like associated therewith, including, without limitation, the U.S. and foreign trademark applications and registrations attached as Schedule 1, any other U.S., foreign trademark or state applications, registrations and common law rights for such marks, goodwill associated with and symbolized thereby, and, in accordance with 15 U.S.C § 1060, the portion of the business to which the mark pertains, all past, present and future claims, counterclaims, credits, causes of action, choses in action, rights of recovery and rights of setoff against third persons for infringements, violations, dilutions or contract breaches, together with the right at law or equity to sue and recover for any past, continuing and/or future infringements, violations, dilutions or contract breaches and collect any resulting recovery of damages, lost profits, legal fees and costs, including from acts which may have occurred prior to the Effective Date, all of the foregoing rights, titles and interests to be held and enjoyed by Assignee, for Assignee's own use and benefit and for the use and benefit of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment, transfer and conveyance had not been made.
