**1. Assignment**

  - (a) take legal action for any infringement of the Trade Marks, passing off or a contravention of any applicable consumer protection legislation, in relation to acts which took place prior to the date of this Assignment, or which takes place prior to the recordal of this Assignment; and
  - (b) apply for and obtain other trade marks claiming priority from, or otherwise based on, the Trade Marks including divisional application(s) or trade marks granted therefrom.
- 1.2. Each party to this Assignment must do all things reasonably necessary to give effect to this clause 1, including by executing further documents.
- 1.3. This Assignment is effective on the date it is signed for the Assignor.

**2. General**

- 2.1. A term or part of a term of this deed that is illegal or unenforceable may be severed from this deed and the remaining terms or parts of the term of this deed continue in force.
- 2.2. This deed may be executed in counterparts. All executed counterparts constitute one document.
- 2.3. This deed is governed by the law of the State of Victoria, Australia and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of the State of Victoria, Australia.




