TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Trademark Assignment"), effective as of January 28, 2016 is made from EDMIT INDUSTRIES INC., a company duly incorporated and organised under the laws of Canada, having its registered address at 1400 Ford Boulevard, Châteauguay, Quebec J6J 4Z2 ("Assignor"), to YALE SECURITY INC., a company duly incorporated and organised under the laws of Delaware, having its registered address at 110 Sargent Drive, New Haven, CT 06511 ("Assignee").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor has sold and assigned, and for greater certainty, does hereby sell and assign to Assignee all of Assignor's right, title and interest in and to the Marks throughout the world, together with all goodwill connected with the use thereof or symbolized thereby, including: (a) all common law rights in the Marks; (b) all registrations, pending applications for registration and rights to file applications for the Marks; (c) all rights of priority and renewals and extensions of applications and registrations for the Marks; (d) all rights to past, present or future claims or causes of action arising out of or related to any unauthorized use, infringement, dilution, misappropriation or other violation of the Marks; and (e) all proceeds arising in connection with any of the foregoing; and

Assignor shall from time to time and upon every reasonable request of Assignee without further consideration but at the expense of Assignee, promptly execute and deliver or cause to be executed and delivered all such further documents, deeds, assurances and instruments and shall do or cause to be done all such further acts and things as may be reasonably required by Assignee to give effect to this Trademark Assignment, whether for more effectually and completely vesting in Assignee the Marks or for the purpose of registration or otherwise.

This Trademark Assignment shall be governed by and construed in accordance with the laws of the Province of Quebec and the Laws of Canada applicable therein (without regard to any conflict of law principles found herein).

This Trademark Assignment shall enure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.
