## ASSIGNMENT OF TRADEMARK RIGHTS

This ASSIGNMENT AGREEMENT (AGREEMENT), whose effective date is March 30, 2016 is by and between:

OCZ STORAGE SOLUTIONS, INC. ("ASSIGNOR"), a corporation of the State of California having a place of business at 6373 San Ignacio Avenue, San Jose, California USA 95119; and

TOSHIBA CORPORATION ("ASSIGNEE"), a corporation organized under the laws of Japan.

1. This AGREEMENT describes an understanding regarding:

Trademark rights in the marks identified on the attached SCHEDULE A entitled, "OCZ STORAGE SOLUTIONS, INC. GURU TRADEMARK PORTFOLIO" ("MARKS") which, through their adoption and continuous use, the ASSIGNOR exclusively holds and ASSIGNEE seeks to acquire rights therein.

2. In that the ASSIGNEE desires to acquire all right, title and interest in and to the MARKS, and the ASSIGNOR has agreed to such a transfer of its rights in the MARKS, the ASSIGNOR and ASSIGNEE agree to the following:

a. In exchange for good and valuable consideration, receipt of which is acknowledged by this AGREEMENT, the ASSIGNOR formally assigns to the ASSIGNEE all right, title and interest, worldwide and in all countries, owned by the ASSIGNOR in the MARKS;

b. The ASSIGNOR transfers the goodwill that it has acquired in connection with the use of and symbolized by the MARKS, including the goodwill of any business in which the MARKS have been used;

c. The ASSIGNEE shall have the right to record this AGREEMENT worldwide, with all national and regional Trademark Offices, and to secure registration of the MARKS as the ASSIGNEE deems appropriate. The ASSIGNOR shall cooperate in good faith to provide information in support of the recordation of this AGREEMENT and in support of the filing and prosecution of any trademark applications filed by the ASSIGNEE on the MARKS.

d. By this AGREEMENT, the ASSIGNOR renounces all goodwill embodied in the MARKS, such that all goodwill arising from the ASSIGNEE's use of the MARKS will inure solely to the benefit of the ASSIGNEE;

e. The ASSIGNOR shall not adopt or use, without prior written consent from the

ASSIGNEE, any variation of the MARKS or any word or mark likely to be similar to or confusingly similar with the MARKS; and

- f. The ASSIGNOR shall not take any action that could be detrimental to the goodwill associated with the MARKS.
3. This AGREEMENT shall be binding on the successors and assignees of the ASSIGNOR and ASSIGNEE.
4. This AGREEMENT is executed by duly authorized representatives of the ASSIGNOR and ASSIGNEE.


