**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of March 31, 2016, is made by Jefferies Finance LLC, as collateral agent (the "Collateral Agent") under the Second Lien Security Agreement, (as defined below). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Second Lien Security Agreement.

**WHEREAS**, in connection with that certain Second Lien Security Agreement dated as of November 3, 2014 among SP Holdco I, Inc ("Holdings"), Surgery Center Holdings, Inc. (the "Borrower"), the other Grantors party thereto from time to time, and the Collateral Agent (the "Second Lien Security Agreement"), the Grantors granted security interests (the "Security Interest Agreements") in certain intellectual property owned by the Grantors, including: (i) all trademarks and copyrights, including those listed on Annex I attached hereto (ii) all renewals and extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each of such copyrights and trademarks; and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing (collectively, the "Intellectual Property Collateral"); and

**WHEREAS**, the Security Interest Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") and in the United States Copyright Office (the "Copyright Office") on the dates and on the reel and frame numbers or volume and document numbers set forth on Annex I hereto.


**NOW THEREFORE**, the Collateral Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Interest Agreements or any other agreement or document delivered in connection with the Second Lien Security Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that such Collateral Agent may have in the Intellectual Property Collateral to the Grantors.

The Collateral Agent agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.
