## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "**Release**") is made as of April 1, 2016 (the "**Effective Date**") by Morgan Stanley Senior Funding, Inc. as collateral agent ("**Agent**"), in favor of the Grantors party to the Second Lien IP Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement dated as of April 15, 2014 (the "**Second Lien IP Security Agreement**"), each entity listed as a Grantor on the signature pages thereto (collectively, the "**Grantors**") granted Agent for the benefit of the Secured Parties under the Second Lien Pledge and Security Agreement dated as of April 15, 2014 modified from time to time, the "Security Agreement"), among the Grantors, the Agent and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**") a security interest in and to, among other things, (i) its Trademarks and Trademark applications, including, without limitation, the Trademarks and Trademark applications listed on Schedule I thereto, and which is attached as Annex A hereto (the "**Trademarks**"); (ii) its Patents and Patent applications, including, without limitation, the Patents and Patent applications listed on Schedule II thereto, and which is attached as Annex B hereto (the "**Patents**"); and (iii) its Copyrights and Copyright applications, including, without limitation, the Copyrights listed on Schedule III thereto, and which is attached as Annex C hereto (the "**Copyrights**");

WHEREAS, the Second Lien IP Security Agreement was recorded with the United States Patent and Trademark Office ("**USPTO**") against the Patents on Schedule I to the Second Lien IP Security Agreement on April 15, 2014 at reel/frame 032694/0227;

WHEREAS, the Second Lien IP Security Agreement was recorded with the USPTO against the Trademarks on Schedule II to the Second Lien IP Security Agreement on April 15, 2014 at reel/frame 5260/0838;

WHEREAS, the Second Lien IP Security Agreement was recorded with the U.S. Copyright Office against the Copyrights on Schedule III to the Second Lien IP Security Agreement; and

WHEREAS, the Agent now desires to terminate the Second Lien IP Security Agreement and release its security interests in and to the Patents, Trademarks and Copyrights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Agent hereby covenants and agrees as follows:

1. The Agent hereby terminates, releases, and discharges its security interest in the Patents, Trademarks and Copyrights and reassigns to Grantors any and all right, title, and interest the Agent may have in or to the Patents, Trademarks and Copyrights.

2. The Agent hereby acknowledges and agrees that Grantors have completely and timely satisfied their obligations in full, and hereby terminates the Second Lien IP Security Agreement. The Agent hereby confirms Grantors shall have no further obligations of any kind under the Second Lien IP Security Agreement.

3. The Agent hereby authorizes and requests that the Commissioner of the USPTO and any other applicable government officer record this Release.

4. The Agent agrees to perform all further acts and execute and deliver all further documents and/or instruments as Grantors may reasonably request to carry out the provisions of this Release.

5. This Release shall be governed by, and construed in accordance with the laws of the State of New York and shall be binding upon the Agent's representatives, successors, assigns and transferees.


