**TERMINATION OF SECURITY INTEREST IN CERTAIN TRADEMARKS AND PATENTS

2. releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the patents and applications more fully described on Exhibit B, without recourse or representation or warranty, express or implied;
3. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given; and,
4. covenants to take all such actions and to execute all such documents as may be desirable to implement the provisions of this Agreement fully and effectively.
