RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

This **RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT** (this "Release") is dated as of April 1, 2016 by Jefferies Finance LLC, in its capacity as collateral agent for the Secured Parties (together with any successors and assigns thereto in such capacity, the "Collateral Agent"), in favor of TransFirst Group, Inc. formerly known as TransFirst Holdings, Inc., TransFirst, LLC, ME Acquisition, LLC and TransFirst Association Sales, LLC (collectively, the "Pledgors"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Pledgors, together with certain other pledgors thereto, and the Collateral Agent entered into that certain First Lien Security Agreement, dated as of November 12, 2014 (the "Security Agreement"), pursuant to which Pledgors executed and delivered to the Collateral Agent that certain First Lien Trademark Security Agreement, dated as of November 12, 2014 (the "Trademark Security Agreement"), for recordation with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 13, 2014 at reel/frame 5400/0762 for TransFirst, LLC, at reel/frame 5400/0696 for TransFirst Association Sales, LLC, at reel/frame 5400/0656 for ME Acquisition, LLC and at reel/frame 5400/0631 for TransFirst Holdings, Inc. (now known as TransFirst Group, Inc.);

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreement, the Pledgors granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in all of the Pledgors' right, title and interest in, to and under the Trademark Collateral (as defined below); and

WHEREAS, the Collateral Agent desires to terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


The term "Trademark Collateral," as used herein, shall mean

- (a) all Trademarks, including, without limitation, the United States registered Trademarks and applications for Trademark registration, listed on Schedule 1 attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

The Collateral Agent, on behalf of the Secured Parties, hereby terminates, releases and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to the Pledgors any right, title or interest of the Collateral Agent in, to or under the Trademark Collateral.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be executed by its duly authorized signatory effective as of the date first above written.
