**NOTICE OF GRANT OF SECURITY INTEREST
IN TRADEMARKS**

Ladies and Gentlemen:

Please be advised that pursuant to that certain Amended and Restated Loan and Security Agreement dated April 1, 2006 (as at any time amended, restated, supplemented or otherwise modified, the "Loan Agreement" – capitalized terms used but not defined herein shall have the meanings ascribed therein), by and among **U.S. LUMBER GROUP, LLC**, a Delaware limited liability company formerly known as U.S. Lumber Group, Inc., a Georgia corporation ("Borrower"), **BANK OF AMERICA, N.A.**, a national banking association, in its capacity as collateral and administrative agent (together with its successors and assigns in such capacity, "Agent") for certain financial institutions party to the Loan Agreement from time to time as Lenders (the "Lenders"), and the Lenders, Borrower has granted (and Borrower does hereby grant) to Agent, for its benefit and the benefit of the other Secured Parties, to secure the prompt payment and performance when due of all of the Obligations, a continuing security interest in and Lien upon any and all right, title and interest of Borrower in and to the trademarks and trademark applications set forth on Schedule 1 attached hereto (collectively, the "Trademarks"), together with the goodwill of Borrower's business connected with and symbolized by the Trademarks, and all proceeds of the Trademarks and such goodwill (together with the Trademarks and such goodwill, collectively, the "Trademark Collateral").


Borrower and Agent, on behalf of itself and the Lenders, hereby acknowledge and agree that (i) the security interest in the Trademark Collateral may only be terminated in accordance with the terms of the Loan Agreement, (ii) the security interest in the Trademark Collateral is not to be construed as an assignment of any trademark or trademark application, and (iii) in the event of any conflict between the terms of this notice and the terms of the Loan Agreement, the terms of the Loan Agreement shall govern.
