**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 4, 2016 (this "Release"), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, as Administrative Agent ("Agent"), in favor of **BRIGHTREE HOME HEALTH & HOSPICE LLC**, a Delaware limited liability company (f/k/a CAREANYWARE, Inc., a Delaware corporation) (the "Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated as of December 31, 2012 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on February 26, 2013, at Reel/Frame No. 4971/0028, the Grantor granted the Agent a security interest in certain collateral pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Agent; and

WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without representation or warranty and at the sole cost and expense of the Grantor, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

The Agent agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at the sole cost and expense of the Grantor).


