RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT

February 18, 2016

Reference is hereby made to that certain Intellectual Property Security Agreement (the "Agreement"), executed by Spira Footwear, Inc., a Delaware corporation ("SPIRA"), in favor of Gibraltar Business Capital, LLC, a Delaware limited liability company ("Gibraltar"), which was recorded in the United States Patent and Trademark Office ("USPTO"), pursuant to which SPIRA assigned and granted to GIBALTAR a continuing security interest in and to all of SPIRA's right, title and interest in and to certain Copyrights, Patents and Trademarks (as defined in the Agreement), including those Patents and Trademarks specifically listed on Exhibit A attached hereto;

WHEREAS, Gibraltar wishes to terminate, cancel, release, relinquish and discharge its continuing security interest, and retransfer and reassign to SPIRA all of SPIRA's right, title and interest in and to the Copyrights, Patents and Trademarks;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Gibraltar hereby terminates, cancels, releases, relinquishes and discharges its continuing security interest, and retransfers and reassigns to SPIRA all of Gibraltar's right, title and interest in and to the Copyrights, Patents and Trademarks and reassigns to SPIRA any and all such right, title and interest in and to the Copyrights, Patents and Trademarks.

Gibraltar hereby agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the termination, cancellation, release, relinquishment, discharge, retransfer and reassignment of the continuing security interest contemplated hereby. The parties hereto or their designees may record this Release before the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, the parties hereto authorize and request that the USPTO record this Release.
