RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT

March 28, 2016

Reference is hereby made to that certain Intellectual Property Security Agreement (the "Agreement"), executed by Basic Sports Apparel, Inc., a Texas corporation ("BASIC"), in favor of First Community Financial, a division of Pacific Western Bank, an Arizona corporation ("FCF"), which was recorded in the United States Patent and Trademark Office ("USPTO"), pursuant to which BASIC assigned and granted to FCF a continuing security interest in and to BASIC's right, title and interest in and to certain Collateral (as defined in the Agreement), including those trademarks and any license rights therein specifically listed on Exhibit A attached hereto ("Trademarks");

WHEREAS, Chowaiki, as successor of interest to FCF, wishes to terminate, cancel, release, relinquish and discharge her continuing security interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Chowaiki, as successor in interest to FCF, hereby terminates, cancels, releases, relinquishes and discharges her continuing security interest in and to the Trademarks.

Chowaiki, as successor in interest to FCF, hereby agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the termination, cancellation, release, relinquishment, discharge, retransfer and reassignment of the continuing security interest contemplated hereby. The parties hereto or their designees may record this Release before the USPTO and in any other offices as may be necessary to carry out the intention of this Release and, to the extent applicable, the parties hereto authorize and request that the USPTO record this Release.
