RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made and given as of the 5th day of April, 2016, by CAPITAL BUSINESS CREDIT LLC, a Delaware limited liability company (the "Secured Party"), in favor of BOXERCRAFT INCORPORATED, a Georgia corporation having its principal office address at 7131 Discovery Blvd., Mableton, Georgia 30126 (the "Debtor").

NOW THEREFORE, for and in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the Secured Party hereby releases, discharges, and terminates its lien in and security interest upon the Trademarks, and transfers and conveys to the Debtor all of the Secured Party's right, title, and interest in the Trademarks.


