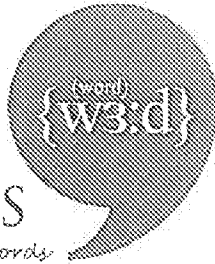

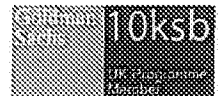

they stipulate and agree the following:

Article 1

The Transferor assigns and transfers to the Transferee, who accepts full,
complete and exclusive ownership of the trademark cited in the
introduction.

Article 2

The payment for the assignment of the trademark has been agreed at €
200,000 (two hundred thousand euros) plus VAT, where applicable.

Article 3

The payment of the price is set as follows:

- € 20,000 are paid by the Transferee to the Transferor by bank
transfer dated 10 December 2015 executed through HSBC on the account
payable to the Transferor at Intesa San Paolo (ref. 140281200W5L);
- € 80,000 shall be paid by the Transferee to the Transferor by 10 June
2016, without interest;
- € 100,000 will be paid by the Transferee to the Transferor by 10
December 2016, without interest.

Article 4

The Transferor guarantees the ownership of the trademark and the regularity of the registrations and the registration requests referred to in the introduction.

The Transferor does not guarantee against the possible refusal of the aforementioned registrations on the part of the competent authorities and against any legal actions brought by third parties and for any reason whatsoever relating to the same registrations.

Article 5

All practices and costs of this document and those required to obtain the recording at the competent authorities shall be borne by the Transferee.

Article 6

This document falls within the scope of VAT, therefore it is subject to registration with application of the tax at a fixed rate, in accordance with article 40 of the Presidential Decree 26 April 1986 No. 131.

Article 7

The representative of the Transferee states that the latter does not have a fixed establishment in Italy and therefore does not have an Italian tax code or VAT registration number.

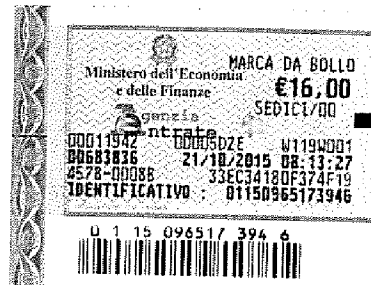


