NOW, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


Assignors hereby convey and assign to Assignee its entire right, title, and interest in said Trademarks together with all the goodwill of the business symbolized by the Trademarks.

This Agreement shall be binding on and shall inure to the benefit of the parties to this Agreement and their successors and assigns, if any.



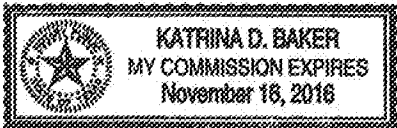
