EXHIBIT 2
GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS is entered into as of April 5, 2016 by and between **BIERY CHEESE CO.**, an Ohio corporation (“Biery Cheese”), **BIER KASE, LLC**, an Ohio limited liability company (“Bier Kase”), **HOMESTEAD – LEASING, INC.**, an Ohio corporation (“Homestead”), and **APOLLO SKY, INC.**, an Ohio corporation (“Apollo”, together with Biery Cheese, Bier Kase and Homestead, collectively, “Pledgor”), and **FIRSTMERIT BANK, N.A.**, a national banking association (“Lender”).

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Pledgor hereby assigns, grants and conveys to Lender, a security interest in (i) all of the Pledgor's right, title and interest in and to the patents (the "Patents") set forth on Schedule A attached hereto, (ii) all of the Pledgor's right, title and interest in and to the trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule B attached hereto, in each case together with (iii) all products of the Patents and Marks, (iv) the goodwill of the businesses symbolized by the Marks, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Patents and Marks or unfair competition regarding the same.

THIS AGREEMENT is entered into to secure the full and prompt performance and payment of all the Obligations of the Pledgor, as such term is defined in the Loan Agreement between the Pledgor and the Lender, dated as of April 5, 2016 (as amended from time to time, the "Loan Agreement"). Upon the occurrence of the Termination Date (as defined in the Loan Agreement), the Lender shall, upon such satisfaction, execute, acknowledge, and deliver to the Pledgor such statements, documents or other instruments in writing as may be reasonably requested by Pledgor releasing the security interest in the Patents and Marks granted under this Agreement with any filing fees to be the sole responsibility of the Pledgor.


