## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 4th day of April, 2016, by PNC BANK, NATIONAL ASSOCIATION, a national banking association, as Collateral Agent ("Agent"), in favor of TOP KNOBS USA, INC., a New Jersey corporation and HARDWARE RESOURCES, INC., a Louisiana corporation (collectively, the "Companies").

WHEREAS, pursuant to the Trademark Security Agreement (the "Security Agreement"), dated as of May 7, 2013, and recorded with the U.S. Patent and Trademark Office on February 16, 2014 at Reel/Frame 5217/0586, the Grantors granted to the Agent, among other collateral as set forth therein, a continuing security interest in all of the Grantors' right, title and interest, in, to and under the Trademark Collateral (as defined in the Security Agreement), including the United States Trademarks listed on the attached Schedule I (the "Marks"); and

WHEREAS, the Grantors have requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Agent hereby terminates, cancels and releases its liens on and security interests in the Trademark Collateral, and assigns, transfers, and conveys to the Grantors any and all right, title and interest in, or to, the Trademark Collateral that the Agent may hold.

The Agent further agrees to execute any other documents and take any further action which is reasonably necessary that the Grantors may reasonably request to effect the intent and

purpose of this Release, provided that all such documents shall be prepared by Grantors' counsel and the cost and expense of such documents and actions shall be borne solely by the Grantors.


