ASSIGNMENT OF TRADEMARK

WHEREAS, Riverside Cement Company (hereinafter referred to as ASSIGNOR), a General Partnership composed of Texas Industries, Inc., a Delaware Corporation, Riverside Cement Company, a California General Partnership, TXI California, Inc., a Delaware Corporation, and TXI Operations, LP, a Delaware Limited Partnership (hereinafter referred to as ASSIGNOR), is the owner of record of the trademark RIVERSIDE, which is registered in the United States Patent and Trademark Office under Registration No. 2,986,967 and which issued August 23, 2005 (the mark and the registration hereinafter referred to collectively as the Riverside Mark); and

WHEREAS, CalPortland Company (hereinafter referred to as ASSIGNEE), a corporation organized under the laws of the state of California, having a mailing address of 2025 E. Financial Way, Glendora, California 91741, is desirous of acquiring the entire right, title, and interest of ASSIGNOR in to and under the Riverside Mark, together with the goodwill of the business associated with the Riverside Mark; and

WHEREAS, by Asset Purchase Agreement dated June 30, 2015, ASSIGNOR sold all of its right, title and interest in and to the Riverside Mark to ASSIGNEE and, pursuant to the Asset Purchase Agreement, agreed to formally assign all of its right, title and interest in the Riverside Mark to ASSIGNEE, on the conditions, representations and warranties contained in the aforesaid Asset Purchase Agreement;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said ASSIGNOR, by these presents, does sell, assign and transfer unto ASSIGNEE the entire right, title and interest in and to said Riverside Mark and the goodwill of the business in connection with which said Riverside Mark is used and all claims for damages by reason of past and present infringement of the Riverside Mark, and the right to sue for and collect such damages.

This assignment is made effective as of October 1, 2015.
