## RELEASE OF GRANT OF SECURITY INTEREST IN IP RIGHTS

This Release of Grant of Security Interest in IP Rights (this "Release") is made as of March 31 2016, by LEAP NOTE, LLC, a Delaware limited liability company, c/o LaunchEquity Partners, 4230 N. Oakland avenue, #317, Shorewood, Wisconsin 53211 (the "Secured Party"), in its capacity as a secured party pursuant to various assignments referred to below (collectively, the "Assignments") for the benefit of DAISY ROCK GUITARS, LLC, a Delaware limited liability company, located at 9772 Sunland Blvd. Shadow Hills, CA 91040, (the "Debtor").

### WITNESSETH:

WHEREAS, an assignment ("Assignment #1") was recorded in the United States Patent and Trademark Office at Reel 5652 and Frames 0333-0336 on October 26, 2015; and

WHEREAS, an assignment ("Assignment #2") was recorded in the United States Patent and Trademark Office at Reel 5657 and Frames 0457-0464 on November 2, 2015; and

WHEREAS, the Debtor has requested that the Secured Party release, and the Secured Party is willing to release the entirety of its security interest and claims of security interest in certain intellectual property collateral as described on Exhibit A attached hereto (the "Released Intellectual Property Collateral"), subject to the terms hereof. For clarity, the Released Intellectual Property Collateral does not include any trademarks identified on the Trademark Assignment Cover Sheets for the Assignments which are also contained in: (i) Reel 5652, Frame 0337 of Assignment #1; and/or (ii) Reel 5657, Frame 0465 of Assignment #2;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. The Secured Party does hereby terminate, release and discharge the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the security interest contained in the Assignment, including, all of the Released Intellectual Property Collateral, which shall include, but is not limited to, the following:

(a) all of Debtor's right, title and interest in, to and under (i) the trademark registrations and applications referred to on Exhibit A hereto and the domain names on Exhibit B attached hereto, (ii) all extension and renewals of any of the foregoing, (iii) all rights in and to the domain names listed in Exhibit B attached hereto; (iv) all the goodwill of the business and the intellectual property connected with the use of and symbolized by the foregoing, (v) the right to sue for past, present and future infringements or dilution of any of the foregoing or for any injury to goodwill, (vi) all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, "Trademarks"); and

(b) any and all agreements providing for the granting of any right in or to Trademarks (whether the Debtor is licensee or licensor thereunder) including those referred to in Exhibit A hereto.

(c) any right, title or interest of the Secured Party in such Released Intellectual Property Collateral shall hereby terminate, cease and become void. The Secured Party hereby assigns, transfers and conveys any and all right, title or interest of the Secured Party in such Released Intellectual Property Collateral to the Debtor.

2. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, at the Debtor's sole cost and expense, as may be reasonably necessary to affect the release of the Released Intellectual Property Collateral contemplated hereby, including, without limitation, UCC filings.

3. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of California. The Parties acknowledge that they are familiar with Section 1542 of the Civil Code of California, which reads as follows:

“A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of execution of the release, which, if known by him must have materially affected his settlement with the debtor.”

The undersigned expressly, knowingly, and intentionally waives and relinquishes any and all rights that it may have under Section 1542.

5. In the event that any term or provision of this Release is determined illegal, invalid, or unenforceable for any reason whatsoever, such illegality, invalidity or unenforceability shall not affect the remaining terms or provisions of this Release, which remaining terms and provisions shall remain in full force and effect.
