Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned corporation does hereby agree to effect a merger (the "Merger") upon the terms and conditions set forth herein.

FIRST: ProValue, LLC, a Delaware limited liability company ("ProValue"), is merging with and into HD Supply Support Services, Inc., a Delaware corporation ("Support Services").

SECOND: The Agreement and Plan of Merger, dated January 26, 2016 (the "Merger Agreement"), by and between ProValue and Support Services has been approved, adopted, certified, executed and acknowledged by each of the aforesaid companies.

THIRD: The name of the surviving corporation will be HD Supply Support Services, Inc. (the "Surviving Corporation").

FOURTH: The Merger will become effective on January 31, 2016, at 11:59 p.m. Eastern time.

FIFTH: The Merger Agreement pursuant to which the Merger is being consummated is on file at the principal place of business of the Surviving Corporation, located at 3100 Cumberland Boulevard, Suite 1700, Atlanta, Georgia 30339.


