RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST

THIS RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST (this "Release") dated as of April 5, 2016, by SPECIALTYCARE IOM SERVICES, LLC, a Delaware limited liability company (the "Releasor").

WHEREAS, on December 20, 2012, ProNerve, LLC ("ProNerve") and General Electric Capital Corporation ("GE") entered into a Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time) (the "Credit Agreement") and a Guaranty and Security Agreement in favor of GE (as the same may be amended, restated, or otherwise modified from time to time), (the "Guaranty and Security Agreement");

WHEREAS, in connection with the Credit Agreement and the Guaranty and Security Agreement, ProNerve executed a Patent and Trademark Security Agreement, dated as of December 20, 2012 (the "Security Agreement"), pursuant to which ProNerve granted to GE, among other collateral, a continuing security interest (the "Security Interest") in all of ProNerve's right, title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule I (the "Trademarks") and United States patents listed on the attached Schedule II (the "Patents");

WHEREAS, said Security Interest was recorded in the United States Patent and Trademark Office on December 21, 2012 at reel/frame 004927/0538 and reel/frame 029531/0626;


