RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of April 7, 2016 (“Effective Date”) from JPMORGAN CHASE BANK, N.A., a national banking association, located at 10 S. Dearborn, 7th Floor Chicago, IL 60603, as Administrative Agent for the benefit of the Lenders (in such capacity, the “Administrative Agent”) to Simpler North America, LLC, a Delaware limited liability company, located at 1 North Dearborn Street, Chicago, Illinois 60602 and Simpler Consulting, LLC, a Delaware limited liability company, located at 1 North Dearborn Street, Chicago, Illinois 60602 (each individually a “Grantor” and collectively the “Grantors”).

WHEREAS, Truven Holding Corp. (formerly known as VCPH Holding Corp.), Truven Health Analytics Inc. (formerly known as Thomson Reuters (Healthcare) Inc.) (the “Borrower”), Lenders and the Administrative Agent have entered into that certain Credit Agreement dated as of June 6, 2012 (as amended, replaced, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, the Borrower and certain of its Affiliates have entered into the Guarantee and Collateral Agreement, dated as of June 6, 2012 (as amended, restated, replaced, supplemented or otherwise modified from time to time, the “Collateral Agreement”) in favor of the Administrative Agent for the benefit of the Secured Parties;

WHEREAS, pursuant to that certain Assumption Agreement, dated as of June 10, 2014, Simpler North America, LLC and Simpler Consulting, LLC, each became Grantors under the Collateral Agreement;

WHEREAS, pursuant to the Collateral Agreement, Grantors and the Administrative Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of June 10, 2014 (the “Trademark Security Agreement”; all capitalized terms used but not defined herein have the definition assigned to them in the Trademark Security Agreement);

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, as security for the prompt and complete payment and performance when due of all of its Obligations, Grantors pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right of setoff against, all of the right, title and interest of such Grantors in, to and under the Collateral, including that set forth on Schedule I attached hereto; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 30, 2014 at Reel 005312, Frame 0675.

NOW, THEREFORE, without recourse and without representation and warranty and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Collateral, (ii) terminates the Trademark Security Agreement with respect to such Collateral and (iii) reassigns all right, title and interest it may have in, to or under the Collateral, together with the goodwill associated therewith, including without limitation any renewals of any of the foregoing, and any proceeds of the foregoing, and any claims against third parties for past, present or future infringement or dilution of the Collateral, to the Grantor.

The Administrative Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without

limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.


This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the law of the State of New York, without regard to any conflicts of laws principles that would require or permit the laws of any other jurisdiction to apply.

The Administrative Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks record this Release.
