ASSIGNMENT OF TRADEMARK

WHEREAS

- A. The Assignor is proprietor of the trademark registration details whereof are set out in Schedule A (hereinafter referred to as the "Trademark").
- B. The Assignor has agreed to assign unto the Assignee the Trademark on the terms set out herein.

The PARTIES AGREE AS FOLLOWS:

1. In pursuance of the said Assignment and in the consideration of the sum of £1 (exclusive of VAT) now paid by the Assignee to the Assignor (receipt and sufficiency of which the Assignor doth hereby acknowledge) the Assignor with full title guarantee hereby assigns and transfers all right, title and interest in the Trademark including all statutory, general and common law rights together with all goodwill attached thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action, to the Assignee.
2. The Assignor shall do and execute or procure that there shall be done any reasonable act in the form of executing any such further documents, deeds, matters, acts and things which are necessary in order to procure the registration of the Assignee as proprietor and beneficial owner of the Trademark the reasonable costs of which will be borne by the Assignee.
3. This Assignment shall be governed by and construed in accordance with the laws of England and Wales.
