Assignee shall hold all right, title and interest in and to the Assigned Marks as fully and exclusively as same would have been held and enjoyed by Assignor had the above assignment not been made.

2. This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin. Any dispute relating to this Assignment shall be resolved solely in the state or federal courts located in Wisconsin.
