RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST

THIS RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST (this “Release”) is made as of April 8, 2016 (“Effective Date”) by THE PRIVATEBANK AND TRUST COMPANY, as Administrative Agent for the Lenders (the “Administrative Agent”), in favor of CONTEXTMEDIA HEALTH, LLC, a Delaware limited liability company (the “Grantor”). All terms not herein defined, have the meanings set forth in the Collateral Agreement or Security Agreement referenced below.

WHEREAS, Grantor and the Administrative Agent are parties to that certain Guaranty and Collateral Agreement dated as of March 20, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) executed in order to secure the prompt and complete payment, observance and performance of all of the Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Collateral Agreement, the Grantor was required to execute and deliver a Patent and Trademark Security Agreement dated as of March 20, 2015 (the “Security Agreement”) to the Administrative Agent for purposes of filing with the United States Patent and Trademark Office (“USPTO”);

WHEREAS, pursuant to the Collateral Agreement and Security Agreement, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other collateral as set forth therein, a continuing security interest in all of the Grantor’s right, title and interest, including goodwill in the trademarks, in, to and under the United States patents and trademarks listed on the attached Schedule A (the “Intellectual Property”);

WHEREAS, the Security Agreement was recorded in the USPTO on March 20, 2015 at Reel/Frame 5482/0666; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Intellectual Property.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges any security interest in and lien upon the Intellectual Property, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the Intellectual Property that the Administrative Agent may hold.

Collateral Agent agrees, at the Grantor’s expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
