**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE, dated as of April 13, 2016, from JPMORGAN CHASE BANK, N.A., a United States national banking association having a principal place of business at 383 Madison Avenue, New York, NY 10179, as collateral agent and administrative agent (the "Agent") for the banks and other financial institutions (collectively, the "Lenders") from time to time parties to the Revolving Credit Agreement (as defined below), to TRUGREEN LIMITED PARTNERSHIP, a Delaware limited partnership having a principal place of business at 1790 Kirby Parkway, Suite 300, Memphis, TN 38138 (the "Grantor"). Capitalized terms used herein without definition are used as defined in the Revolving Credit Agreement, dated as of January 14, 2014, among the Agent, the Grantor, TruGreen Holding Corporation, the Lenders and the other parties thereto (as amended, supplemented or otherwise modified from time to time, the "Revolving Credit Agreement") and the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of January 14, 2014 (the "Security Agreement"), made by the Grantor, TruGreen Holding Corporation and the Subsidiary Guarantors in favor of the Agent, a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain Trademarks (as defined below);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 16, 2014, at Reel 5194, Frame 0595; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Trademarks: The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest in and to all United States trademarks, service marks, trade names, trade dress or other indicia of trade origin or business identifiers, trademark and service mark registrations, and applications for trademark or service mark registrations (except for "intent to use" applications for trademark or service mark

registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of said Act has been filed), and any renewals thereof, including, without limitation, each registration and application identified in Schedule I hereto, and including, without limitation, (i) the right to sue or otherwise recover for any and all past, present and future infringements or dilutions thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past or future infringements thereof), and (iii) all other rights corresponding thereto in the United States and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto in the United States, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin or business identifiers.

2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.


3. Further Assurances: The Agent shall execute and deliver to the Grantor (at the sole cost and expense of the Grantor) all releases or other documents (including without limitation UCC termination statements) necessary or reasonably desirable for the release of such Security Interest, as the Grantor may reasonably request.
