**NOTICE AND CONFIRMATION OF GRANT OF
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "**Agreement**"), dated as of April 14, 2016, is made by CRAFT REVOLUTION, LLC, a Delaware limited liability ("Craft Revolution"), SOUTHERN TIER BREWING COMPANY, LLC, a New York limited liability company ("Southern Tier"), and VICTORY BREWING COMPANY, LLC, a Pennsylvania limited liability company ("**Victory**" and, together with Craft Revolution and Southern Tier, the "**Grantors**" and each a "**Grantor**"), in favor of Wells Fargo Bank, National Association (the "**Lender**"), for its benefit and the benefit of certain of its Affiliates, in connection with that certain Amended and Restated Credit Agreement (the "**Credit Agreement**") dated as of the date hereof, between Craft Revolution, LLC, as borrower, and the Lender.

W I T N E S S E T H:

WHEREAS, in connection with the Credit Agreement, the Grantors, together with Southern Tier Distilling, LLC, entered into that certain Amended and Restated Security Agreement dated as of the date hereof (as amended, supplemented, waived or otherwise modified from time to time, the "**Security Agreement**"), in favor of the Lender, for its benefit and the benefit of certain of its Affiliates; and

WHEREAS, pursuant to the Security Agreement, each Grantor granted to the Lender, for its benefit and the benefit of certain of its Affiliates, a security interest in such Grantor's Intellectual Property (as defined in the Security Agreement), including, without limitation, Trademarks (as defined in the Security Agreement); and

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lender to from time to time make and maintain extensions of credit under the Credit Agreement and the Related Credit Arrangements, each Grantor agrees, for the benefit of the Lender and its Affiliates, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, capitalized terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement or the Security Agreement.

SECTION 2. Grant of Security Interest. Each Grantor hereby confirms that pursuant to the Security Agreement that such Grantor granted to the Lender, for its benefit and the benefit of certain of its Affiliates, a security interest in all of the Trademarks of such Grantor (including, without limitation, those items listed on Schedule A hereto), any and all goodwill associated therewith, and all proceeds and products of any and all of the Trademarks of such Grantor, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations.

SECTION 3. Purpose. This Agreement has been executed and delivered by each Grantor for the purpose of recording the security interest granted pursuant to the Security Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Security Agreement. The Security Agreement (and all

rights and remedies of the Lender thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgement. Each Grantor hereby further acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademarks are fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.


SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.





