**TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (the “Trademark Release”) is conveyed as of June 24, 2014, by **BANK OF AMERICA, N.A.**, as Administrative Agent, for itself and the other Lenders, in favor of **DENTAQUEST, LLC** successor by merger to DentaQuest Ventures, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement (as defined below).

**WHEREAS**, the Grantor entered into that certain Credit Agreement, dated as of February 2, 2007, with the Administrative Agent and the other Lenders party thereto (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

**WHEREAS**, pursuant to the Credit Agreement the Grantor entered into that certain Trademark Security Agreement, dated as of February 2, 2007 (the “Trademark Agreement”), granting a security interest in favor of the Administrative Agent, in and to certain intellectual property held by the Grantor, including without limitation the Trademark Collateral (as defined in such Trademark Agreement) (the “Security Interest”), including the trademark registrations and applications listed on Schedule A;

**WHEREAS**, notice of the Security Interest was recorded with the United States Patent and Trademark Office on February 19, 2007 at Reel 3483, Frame 0479; and

**WHEREAS**, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Trademark Release, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent, hereby releases the Security Interest and hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Security Interest.

2. Recordation of Trademark Release. This Trademark Release has been executed and delivered by the Administrative Agent for the purpose of recording the release of the Security Interest with the United States Patent and Trademark Office. The Administrative Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks record this Trademark Release.

3. Governing Law. This Trademark Release shall be construed in accordance with the laws of the State of New York.
