DISCHARGE OF SECURITY INTEREST
(Trademarks)

WHEREAS, GO WIRELESS, INC., a Nevada corporation (the “Grantor”) granted a security interest in the United States Trademarks listed in Exhibit A attached hereto and in the other collateral described in the Security Agreement (as defined below) (collectively, the “Collateral”) to SunTrust Bank, as Administrative Agent (the “Grantee”), pursuant to that certain Guaranty and Security Agreement (the “Security Agreement”) dated May 23, 2014, in order to secure repayment of certain amounts owing to Grantee and the other lenders (the “Lenders”) from time to time party to that certain Revolving Credit and Term Loan Agreement dated May 23, 2014 among the Grantor, the Grantee, and the Lenders, as amended, restated, or otherwise modified from time to time (the “Credit Agreement”);


WHEREAS, an Intellectual Property Security Agreement (the “IP Security Agreement”) between the Grantor and the Grantee with respect to the trademarks listed in Exhibit A was entered into on May 23, 2014, and was recorded in the records of the United States Patent and Trademark Office (the “USPTO”) on May 23, 2014, and such recordation is located on Reel 5285 at Frame 0916 of the USPTO; and

WHEREAS, the Grantee desires to release the marks listed in Exhibit A from the IP Security Agreement.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Grantee of the full amount of the indebtedness described in the Credit Agreement and Security Agreement, the Grantee hereby (a) terminates, releases and discharges all the security interests granted by the IP Security Agreement, being the security interests granted in respect of the patents, trademarks, copyrights and all other Collateral and (b) acknowledges, confirms and agrees that the IP Security Agreement is discharged, released and terminated and of no further force or effect.
