**RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS**

THIS RELEASE OF PATENT, TRADEMARKS SECURITY INTEREST ("Release") is made and effective as of April 8, 2016 and granted by TriState Capital Bank, a Pennsylvania state chartered bank (the "Grantee") parties to the Amendment No. 1 to Amended and Restated Credit Agreement, dated as of April 1, 2014, in favor of Spectro, Inc., a Massachusetts corporation ("Grantor").

WHEREAS, Grantor has promptly paid and performed all its Secured Obligations (as defined in the Security Agreement), and Grantee desires to release its security interests in and liens upon the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby releases its lien on and security interest in all Grantor's right, title and interest in and to the Collateral and reassigns any and all interest it may have in such Collateral to Grantor.
