For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns unto Assignee all of its rights, title and interest in and to the Transferred Intellectual Property together with the goodwill of the business thereby symbolized, and any registrations and pending registrations of the subject Transferred Intellectual Property.

Assignor further assigns to Assignee all rights to sue for and receive damages accruing from past infringement of the Transferred Intellectual Property.

Assignor further undertakes that upon request of Assignee it will execute all papers, make all rightful oaths, testify on behalf of Assignee, and do all other lawful acts necessary to carry out the intent of this Assignment, as well as to provide other material, information or assistance as Assignee may consider necessary to carry out the intent of this Assignment.

This Assignment is binding upon Assignor and Assignee, their respective successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.
