## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), dated as of April 20, 2016, is made by Skandinaviska Enskilda Banken AB (publ) (the "Secured Party") in favor of Xerox AB (the "Grantor").

**WHEREAS**, the Grantor and certain of its affiliates were parties to a financing arrangement with the Secured Party under a term loan and revolving facilities agreement dated as of July 5, 2006 (as amended from time to time, the "Facilities Agreement"), which required the Grantor to grant a security interest in those certain Trademarks listed on Exhibit A hereto (the "Trademarks");

**WHEREAS**, such security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office (the "USPTO") on August 25, 2006, at Reel 3378 and Frame 0039;

**WHEREAS**, the Grantor is the sole owner of the Trademarks; and

**WHEREAS**, the Grantor has satisfied the terms of the Facilities Agreement and the Secured Party has agreed to release its security interest in the Trademarks and related property.



**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases and discharges all liens and security interests granted to the Secured Party in the Trademarks and related property and reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademarks and related property, and further agrees that it shall execute all other documents and do all other acts in writing by the Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Termination and hereby authorizes the Grantor or its designee to record with the USPTO the release set forth herein and the Grantor's right, title and interest in and to the Trademarks and related property and other Trademark Collateral.

This Termination shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
