## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of January 1, 2016 (this "Release") is made by TD Bank, N.A. Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Debtor's expense, as may be reasonably necessary to effect the release of the security interest in the Trademarks contemplated hereby.


