RELEASE OF PATENT AND TRADEMARK SECURITY INTERESTS dated as of April 20, 2016 (this "Release"), by JPMORGAN CHASE BANK, N.A., as Administrative Agent under the Credit Agreement (in such capacity, the "Administrative Agent") and Collateral Agent under the US Collateral and Guaranty Agreement (in such capacity, the "US Collateral Agent") and JPMORGAN CHASE BANK, N.A., TORONTO BRANCH, as Collateral Agent under the Canadian General Security Agreement (the "Canadian Collateral Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement, the US Collateral and Guaranty Agreement or the Canadian General Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of November 28, 2001, as amended and restated as of September 30, 2011, as further amended and restated as of May 18, 2012, and as further amended as of December 14, 2015 (as further amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Compass Minerals International, Inc., a Delaware corporation (the "US Borrower"), Compass Minerals UK Limited (the "UK Borrower"), Compass Minerals Canada Corp. (the "Canadian Borrower"; the US Borrower, the UK Borrower and the Canadian Borrower, collectively, the "Borrowers" and each individually, a "Borrower"), the lenders from time to time parties thereto (the "Lenders") and the Administrative Agent, (ii) the US Collateral and Guaranty Agreement dated as of November 28, 2001, as amended and restated as of December 22, 2005 and as further amended by the First Amendment dated as of September 30, 2010 (the "US Collateral and Guaranty Agreement"), among the US Borrower, each other subsidiary of the US Borrower party thereto and the US Collateral Agent, (iii) the Canadian General Security Agreement dated as of November 28, 2001, as amended on December 9, 2005, as further amended on December 22, 2005 and as further amended on September 30, 2010 (as further amended, restated, supplemented, waived or otherwise modified from time to time, the "Canadian General Security Agreement"), among the Canadian Borrower, the other subsidiaries of the US Borrower party thereto and the Canadian Collateral Agent and (iv) the Patent and Trademark Security Agreement dated as of September 30, 2010, among the US Borrower, the Canadian Borrower, the subsidiaries of the US Borrower listed on Schedule I hereto (the US Borrower, the Canadian Borrower and the subsidiaries of the US Borrower listed on Schedule I hereto, collectively, the "Grantors"), certain other subsidiaries of the US Borrower party thereto, the US Collateral Agent and the Canadian Collateral Agent (such documents set forth in clauses (i) through (iv), the "Security Agreements").

B. Pursuant to the Security Agreements, each Grantor granted to the US Collateral Agent and the Canadian Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of such Grantor in, among other things, (i) the patents and patent applications of such Grantor set forth on Schedule II hereto (collectively, the "Patent Collateral"), which security interests were recorded with

the United States Patent & Trademark Office on October 26, 2010 at Reel/Frame 025192/0220 and (ii) the trademarks and trademark applications of such Grantor set forth on Schedule III hereto (collectively, the "Trademark Collateral"), which security interests were recorded with the United States Patent & Trademark Office on October 26, 2010 at Reel/Frame 004304/0082.

C. Pursuant to the Payoff Letter dated as of April 20, 2016, among the Borrowers and the Administrative Agent, the Administrative Agent agreed to release any and all security interests it may have in the Patent Collateral and Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the US Collateral Agent and the Canadian Collateral Agent do hereby release, relinquish and discharge any and all security interests they have against the Patent Collateral and the Trademark Collateral. The US Collateral Agent and the Canadian Collateral Agent agree to make filings with the United States Patent and Trademark Office and other necessary filings, in each case reasonably requested by any Borrower and at the expense of such Borrower, to evidence the release and termination of the US Collateral Agent's security interests and the Canadian Collateral Agent's security interests in the Patent Collateral and the Trademark Collateral.




