This ASSIGNATION is made:

by

- (1) **HAMDEEN INCORPORATED LIMITED**, a company incorporated in the Isle of Man, (registered number 105383C) and having its registered office at 8a The Village Walk, Onchan, Isle of Man IM3 4EA (hereinafter referred to as "the Assignor");

in favour of

- (2) **WEATHERFORD SWITZERLAND TRADING AND DEVELOPMENT GMBH**, a company incorporated in Switzerland (registered number CH-170.4008.546-5) and having its registered office at Alpenstrasse 15, Zug (6304), Switzerland (hereinafter referred to as "the Assignee").

**WHEREAS:**

- (A) The Assignor is the registered proprietor of certain registered trade marks (as hereinafter defined).
- (B) The Assignor has agreed, pursuant to an agreement between the parties (as hereafter defined) to assign *inter alia* the said registered trade marks and now assigns such to the Assignee on the terms and conditions hereof.

**NOW IT IS HEREBY AGREED AS FOLLOWS:**

**1. Definitions**

- 1.1. In this Assignment the following terms shall have the following meanings unless the context otherwise requires:

"BPA" means the Business Purchase Agreement between the parties dated 12 August 2009;

"Registered Trade Marks" means the registered trade marks listed in the Schedule; and

"Trade Marks" means the names, logos and marks for "Hippo", "Pipeslip" and "Hamdeen", together with the Registered Trade Marks.

- 1.2. In this Assignment unless the context otherwise requires:-

1.2.1. references to the singular include the plural and vice versa;

1.2.2. references to Clauses and the Schedule are to clauses and the schedule to this Assignment;

1.2.3. headings to Clauses and the Schedule are inserted for convenience only and shall not affect the construction or interpretation of this Assignment.

**2. Assignment**

- 2.1. In consideration of the sums set out in the BPA (receipt of which is acknowledged by the Assignor), the Assignor hereby assigns to the Assignee:-
- 2.1.1. its entire right, title and interest in and to the Trade Marks;
  - 2.1.2. any common law rights and the goodwill associated with, symbolised by or attaching to the Trade Marks but no other goodwill; and
  - 2.1.3. all rights and powers arising from or attaching to its right, title and interest in and to the Trade Marks and the right to institute and maintain proceedings for infringement or wrongful use of the Trade Marks or for passing off whether occurring prior to the date hereof or hereafter; and
  - 2.1.4. the right to apply for, prosecute and obtain registered trade mark protection throughout the world in respect of the Trade Marks, to the intent that the grant of any protection thereon will be in the name of and vest in the Assignee.

**3. No Warranties**

For the avoidance of doubt, except as set out in the BPA, the Assignor gives no warranties or undertakings and makes no representations in relation to the Trade Marks whatsoever, including, without limitation, as to its title to them, or as to the Assignee's use of them, including as to infringement of third party rights and any warranties, terms, undertakings, representations or conditions which may have been otherwise implied by law, statute or otherwise into this Assignment relating to the Trade Marks or otherwise are hereby expressly excluded to the fullest extent permitted by law.

**4. Further Assurance**

- 4.1. At the request and expense of the Assignee, the Assignor shall render all necessary assistance to the Assignee, and shall execute, and procure or arrange for the execution of, such other assignments, documents and forms and do such further things as may be reasonably required to record the rights assigned to the Assignee hereunder in the relevant trade mark registers, to vest absolutely the full property, right, title and interest in the Trade Marks in the Assignee or to fully vest in the Assignee the rights assigned to it hereunder, to confer on the Assignee all rights of action available to the Assignor in relation to any infringement of the Trade Marks by third parties and otherwise to give the Assignee the full benefit of this Assignment.
- 4.2. The Assignor hereby irrevocably appoints the Assignee to be its Attorney for the purpose of signing its name and on its behalf any document, form or authorisation, falling within the terms of Clause 4.1.

## 5. Governing Law

This Assignment shall be governed by and construed in accordance with Scots law and the parties hereby prorogate the non-exclusive jurisdiction of the Scottish courts over all disputes arising from, or connected to, this Assignment.


