TERMINATION OF TRADEMARK MORTGAGE AND RELEASE OF LIENS

This Termination of Trademark Mortgage and Release of Liens (this "Release") is made this 20th day of April 2016 by **BANK OF AMERICA, N.A.**, as successor in interest by virtue of merger to Merrill Lynch Commercial Finance Corp. ("Bank of America") in favor of **CHESAPEAKE SYSTEM SOLUTIONS, INC.** ("Chesapeake"), and states as follows:

WHEREAS, on or about October 12, 2005 Chesapeake granted a Trademark Mortgage to Merrill Lynch Business Financial Services Inc. ("MLBFS"), recorded among the assignment records of the Patent & Trademark Office on January 23, 2009, at REEL 3924, FRAME 0315 , and on October 19, 2005, at REEL 3177, FRAME 0769 (the "Trademark Mortgage"); and

WHEREAS, on or about December 15, 2008, GE Business Financial Services Inc., as successor to MLBFS, assigned its rights in the Trademark Mortgage to Merrill Lynch Commercial Finance Corp ("MLCF") and to confirm the same recorded a Confirmatory Assignment of Security Interest in Intellectual Property against the trademarks set forth on Schedule 1 attached hereto (collectively, the "Trademarks") among the assignment records of the Patent & Trademark Office on January 23, 2009, at REEL 3924, FRAME 0365 (the "Confirmatory Assignment "); and

WHEREAS, Bank of America is the successor in interest by merger to MLCF; and


WHEREAS, the debt underlying the security interests reflected in the Trademark Mortgage and Confirmatory Assignment were paid off several years ago and Chesapeake has requested that Bank of America acknowledge the release of the lien reflected in such instruments:

NOW WHEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America hereby covenants, agrees and acknowledges as follows:

1. The recitals set forth above are incorporated herein by reference.
2. The liens, security interests and other rights of Bank of America set forth in the Trademark Mortgage and Confirmatory Assignment be and the same are hereby unconditionally and expressly released, discharged, cancelled, terminated and deemed satisfied, and as result hereof Bank of America no longer claims any rights, title or interest in the trademarks and other property rights identified therein.
3. All of the right, title and interest in the Trademarks, including the security interest and any other liens are hereby retransferred, reconveyed and reassigned to Chesapeake.
4. Chesapeake is hereby authorized to file and record this Release by and among the assignment records of the US Patent & Trademark Office.
