ASSIGNMENT AND ASSUMPTION AGREEMENT

Nothing contained herein is intended in any way to limit or affect Assignor's obligation to sell, convey and transfer the Assets free and clear of all mortgages, pledges, security interests, liens, claims, charges, options, conditional sales agreements, encumbrances or restrictions of any kind and nature.
- 2. <u>Assumption</u>. Assignee hereby assumes all the Assets and agrees to perform all obligations of Assignor relating to the Assets arising from and after the Effective Date; provided, Assignor shall perform and remain liable with respect to all obligations arising prior to the Effective Date.




