**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement, (this "Release Agreement"), dated as of April 14, 2016, is made by Canadian Imperial Bank of Commerce, (the "Agent") in favor of Twin-Star International, Inc. (the "Grantor").

WHEREAS, the Grantor and the Agent entered into that certain Trademark Security Agreement, dated as of April 24, 2007, whereby the Grantor granted the Agent a security interest in certain trademarks of the Grantor, including the trademarks and trademark applications listed on Schedule A attached hereto (the "Secured Trademarks"); and

WHEREAS, the Trademark Security Agreement for the Secured Trademarks was recorded with the United States Patent and Trademark Office on April 25, 2007 at Reel 3529, Frame 0090;

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, the Agent has agreed to terminate and release its security interest and all of its right, title and interest in each of the Secured Trademarks, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:


1. Release and Assignment. The Agent hereby discharges, terminates and releases its security interest in all of the Secured Trademarks, and the Agent hereby assigns and transfers to the Grantor, without recourse, all of the Agent's right, title and interest in and to each of the Secured Trademarks and the related registrations and goodwill, effective as of the date set forth above.

2. Further Assurances. The Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantors' sole cost and expense.
