RELEASE OF TRADEMARK SECURITY INTEREST


For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America, N.A., as administrative agent (the "Administrative Agent"), whose address is 135 S. LaSalle St., Chicago, Illinois 60603, pursuant to that certain Amended and Restated Collateral Agreement dated as of September 4, 2014, by and among the grantors from time to time party thereto (each a "Grantor" and collectively, the "Grantors") and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "Collateral Agreement"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Collateral Agreement and the Notice of Grant of Security Interest in Trademarks dated as of February 27, 2015, among the Administrative Agent and Heartland Commerce, Inc. ("Heartland Commerce") (the "Trademark Security Agreement"), including, without limitation, the trademarks listed on Schedule 1 attached hereto (collectively, the "Released Collateral"), arising from the Collateral Agreement and the Trademark Security Agreement, which was recorded in the United States Patent and Trademark Office ("PTO") on or about March 2, 2015, against the United States trademarks listed on Schedule 1 at Reel/Frame Numbers 5469/0412. The Administrative Agent hereby releases, retransfers and reassigns to Heartland Commerce the security interest and all of the Administrative Agent's right, title and interest in, to and under the Released Collateral. The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of Heartland Commerce, such further instruments, documents and release forms as Heartland Commerce may reasonably request or are required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release of Trademark Security Interest shall be binding upon the Administrative Agent, its legal representatives, assigns and successors. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.
