TERMINATION AND RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT

This TERMINATION AND RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT ("Termination and Release") dated as of April 22, 2016, is made from Wilmington Trust, National Association, as administrative agent (in such capacity, the "Administrative Agent") under the Credit Agreement referred to below to ALIANTE GAMING, LLC, a Nevada limited liability company (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (defined below) or the Trademark Assignment (defined below), as applicable.

WITNESSETH:

WHEREAS, Grantor, as borrower, has entered into that certain Credit Agreement dated as of November 1, 2011 with the Administrative Agent and the lenders from time to time party thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, Grantor executed that certain Trademark Collateral Assignment dated as of November 1, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Assignment"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 4658 Frame 0512, pursuant to which the Grantor granted a security interest to the Agent, for the benefit of the Secured Parties, in the Collateral (as defined in the Trademark Assignment) (the "Trademark Collateral"), including certain trademarks and/or trademark applications listed on Schedule 1 hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral, including those trademarks set forth on Schedule 1.
2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of Agent's right, title, and interest in and to the Trademark Collateral.
