## **2/ TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT**

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT (this "Agreement"), effective as of the Closing Date, is made and entered into by and between Alcatel-Lucent USA Inc., a Delaware corporation with its principal place of business at 600-700 Mountain Avenue, Murray Hill, New Jersey 07974-0636, USA ("Seller") and China Infotech (Luxembourg) S.A., a Luxembourg company with its address at 11-13, Boulevard de la Foire, L-1528 Luxembourg, Grand-Duché du Luxembourg ("Buyer").

WHEREAS, Seller and other companies of the Alcatel-Lucent group and China Huaxin Post and Telecommunication Economy Development Center ("Huaxin"), an indirect shareholder of the Buyer, entered into a Share and Asset Purchase Agreement dated May 29, 2014 (the "SAPA") whereby Seller shall sell and Huaxin acquire a certain Business; and

WHEREAS, Seller is the owner of the Assigned Trademarks and Domain Name (as defined below) which are exclusively associated with the Business.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein and in the SAPA, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and accepted, the parties hereto agree as follows:

### ARTICLE 1 – DEFINITIONS

1.1 Capitalized terms not otherwise defined in this Agreement shall have the meaning ascribed to them in the SAPA.

1.2 "Assigned Trademarks and Domain Name" shall mean the trademarks and domain name listed in Schedule A and Schedule B hereto.

### ARTICLE 2 – PURCHASE AND SALE

2.1 Seller hereby sells, assigns and transfers to Buyer, which accepts, all of Seller's rights, title and interest in and to the Assigned Trademarks and Domain Name, including any rights of priority and any common law rights relating thereto throughout the world, together with the goodwill of the business connected with and symbolized by the Assigned Trademarks and Domain Name and the current registrations thereof. As of the Closing Date, Buyer shall enjoy all benefit of the Assigned Trademarks and Domain Name and all rights of ownership of the Assigned Trademarks and Domain Name, including, without limitation, the rights to exploit, use, license and dispose of the Assigned Trademarks and Domain Name and the rights to all proceeds of the foregoing, including the rights to institute, continue or defend any past, present or future suit or action relating to the Assigned Trademarks or Domain Name and to recover damages for any past, present or future infringement thereof. To that effect, Buyer is subrogated to all Seller's rights and actions, in substitution for those of Seller.

2.2 Buyer shall bear all costs associated with the recordation of the transfer of ownership of the Assigned Trademarks and Domain Name with the relevant authorities. Seller shall cooperate fully to that effect and shall provide all corresponding information, documents and records in its possession, sign all documents and instruments, take all rightful oaths and affidavits, and do all other acts necessary or desirable to secure in said Assignee, its successors or assigns, the title to and full benefit of all rights hereby assigned, as reasonably requested by Buyer.

### ARTICLE 3 – CONSIDERATION

3.1 This Agreement is executed in consideration of the execution of the SAPA.

#### ARTICLE 4 – REPRESENTATIONS AND WARRANTIES

- 4.1 Seller hereby represents and warrants to Buyer as of the Closing:
- a) Seller is the sole owner of all rights, title and interest in and to the Assigned Trademarks and Domain Name, and Seller has the authority to grant the assignment set forth in the above Section 2.1;
  - b) All necessary registration fees due in connection with the Assigned Trademarks and Domain Name have been paid, and all necessary documents in connection with the Assigned Trademarks and Domain Name have been filed with the relevant authorities for the purposes of prosecuting and establishing ownership the Assigned Trademarks and Domain Name; and
  - c) To the knowledge of Seller, there is no pending or threatened legal action or claim concerning third parties in which the Assigned Trademarks and Domain Name are involved.

4.2 EXCEPT AS SET FORTH IN THE ABOVE SECTION 4.1 AND IN THE SAPA, THE ASSIGNED TRADEMARKS AND DOMAIN NAME ARE ASSIGNED “AS IS” WITH ALL FAULTS, LATENT OR PATENT. SELLER MAKE NO OTHER REPRESENTATION OR WARRANTY, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, NO REPRESENTATION OR WARRANTY THAT THE ASSIGNED TRADEMARKS AND DOMAIN NAME AND THEIR USE WILL NOT INFRINGE ANY TRADEMARK, TRADE NAME, OR ANY OTHER INTELLECTUAL PROPERTY RIGHT OF ANY THIRD PARTY.

#### ARTICLE 5 – RECORDATION

5.1 Seller hereby authorizes the relevant trademark registration authority in any country to record this Agreement.

5.2 Seller shall apply, at its own cost, for the recording of the release of the registered Liens with all relevant authorities within a deadline of two (2) months from the Effective Date.

#### ARTICLE 6 – NOTICES

As an exception to Section 12.6 of the SAPA, notices to Seller under this Agreement shall be sent to:

#### ARTICLE 7 – GENERAL

7.1 This Agreement shall be governed by and enforced in accordance with French law, excluding any choice of law rules that may direct the application of the laws of another jurisdiction.

7.2 This Agreement being ancillary to the SAPA, it shall be governed by all applicable provisions of the SAPA, including but not limited to jurisdiction provisions. In case of inconsistency or divergence of interpretation as between this Agreement and the SAPA, the latter shall prevail.


7.3 This Agreement shall be binding upon and shall inure to the benefit of Buyer and its respective successors and assigns.


