Triage Management Services, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the written consent of all of its members, adopted a resolution proposing and declaring advisable the following amendment to the Amended and Restated Certificate of Incorporation, as amended, of said corporation (the "Amendment"):


RESOLVED, that the Amended and Restated Certificate of Incorporation of Triage Management Services, Inc., as amended, originally filed with the Secretary of State of Delaware on October 9, 2007 be amended by changing the First Article thereof so that, as amended, said Article shall be and read in its entirety as follows:

"FIRST: The name of the corporation is TMC Liquidation Corp. (the "Corporation")."

SECOND: At a special meeting of the stockholders called and held in accordance with Section 222 of the DGCL, a majority of the outstanding stock entitled to vote and a majority of the outstanding stock of each class entitled to vote thereon as a class voted in favor of the Amendment.

THIRD: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the DGCL.
