Declaration of Correction

1. I am counsel of record for Robert M. Thomas and Social(K), Inc. This Declaration is based upon my personal knowledge.
2. This Declaration of Correction serves to correct the chain of title in the SOCIAL K service mark, Registration No. 3,114,326.
3. On December 10, 2014 ExpertPlan, Inc. and Robert M. Thomas entered into a Trademark Purchase Agreement effective December 10, 2014 for the sale of the SOCIAL K service mark from ExpertPlan to Mr. Thomas.
4. The Trademark Purchase Agreement between ExpertPlan and Mr. Thomas contained all the language of a trademark assignment. It was made contingent in part upon the release of two security interests (First and Second Liens) granted by ExpertPlan in the SOCIAL K service mark.
5. On January 28, 2015 ExpertPlan recorded the release of the two security interests in the SOCIAL K registration.
6. On January 28, 2015, the release of the First Lien was recorded at Reel/Frame 5448/0467 (Assignment 6 in the SOCIAL K chain of title).
7. On January 28, 2015, the release of the Second Lien was recorded at Reel/Frame 5448/0480 (Assignment 7 in the SOCIAL K chain of title).
8. On February 10, 2015, upon seeing the recordation of the release of the First and Second Liens in the SOCIAL K service mark, in my capacity as counsel for Robert Thomas, I recorded the Trademark Purchase Agreement between ExpertPlan, Inc. and Robert M. Thomas at Reel/Frame 5457/0766 (Assignment 5 in the chain of title).
9. On February 12, 2015 upon receiving the Notice of Recordation of the Trademark Purchase Agreement between ExpertPlan and Mr. Thomas, I recorded a subsequent assignment dated February 12, 2015 from Mr.


Thomas to his corporation, Social(K), Inc. This document is listed as Assignment 8 in the chain of title and was recorded at Reel/Frame 5459/0451 (Assignment 8 in the chain of title).

10. On March 9, 2016, in my capacity as counsel for Social(K), Inc. I began the work to renew the SOCIAL K service mark registration when I noticed that the record owner was listed as Robert Thomas rather than his corporation, Social(K), Inc.
11. On March 9, 2016, after several hours of investigation, I discovered that subsequent to my recordation of the Trademark Purchase Agreement between ExpertPlan and Robert Thomas (5457/0766) and the assignment from Robert Thomas to Social(K), Inc. (5459/0451), outside counsel for ExpertPlan, Inc. recorded a Trademark Assignment between ExpertPlan, Inc. and Robert M. Thomas, effective March 2, 2015 at Reel/Frame 5470/0594 (Assignment 9 in the chain of title).
12. After several rounds of discussion with my clients, Robert Thomas and Social(K), Inc., and counsel for ExpertPlan, I determined that the Assignment 5 (5457/0766) and Assignment 8 (5459/0451) should be disregarded.
13. **The purpose of this Declaration is to instruct the USPTO and others viewing the SOCIAL K chain of title to please disregard the Trademark Assignment recorded at Reel/ Frame 5459/ 0451 (Assignment 8).**
