RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“**Agreement**”) is delivered as of March __, 2016, by **COMERICA BANK**, a Texas banking association and authorized foreign bank under the Bank Act (Canada) (“**Bank**”), **SPECTRA7 MICROSYSTEMS CORP.**, formerly known as Fresco Microchip Inc., a company existing under the Business Corporation Act (Ontario) (“**Grantor**”). Capitalized terms not otherwise defined herein have the meaning set forth in the Security Agreement (as defined below).

Grantor granted to Bank a continuing security interest in Grantor’s entire right, title and interest in and to all of the Intellectual Property Collateral (as such term is defined in that certain Intellectual Property Security Agreement, dated as of February 5, 2013, by and among Bank and Grantor (the “**Security Agreement**”)), including, without limitation, the Intellectual Property Collateral referenced on Exhibit A attached hereto.

Bank hereby terminates and releases in full all of its right, title and interest in and to any and all liens and security interests it may have upon the Intellectual Property Collateral granted pursuant to the Security Agreement and reassigns to Grantor all right, title and interest of Bank in the Intellectual Property Collateral.

Bank agrees to execute, deliver and file, at the request and sole expense of Grantor, such further instruments, documents and releases as Grantor may reasonably request to release, terminate and extinguish any such liens and security interests upon the Intellectual Property Collateral.
