THIS ASSIGNMENT is made the 16th day of March Two Thousand and Sixteen

BETWEEN LIFES 2 GOOD LIMITED, an Irish company of Unit 7, Racecourse Business Park, Ballybrit, Galway, Ireland (hereinafter referred to as the "Assignor") of the First Part,

AND VIVISCAL LIMITED (formerly Viviscal Holdings Limited), an Irish company of Unit 7, Racecourse Business Park, Ballybrit, Galway, Ireland (hereinafter referred to as the "Assignee") of the Second Part.

WHEREAS

- (a) The Assignor is the registered proprietor of Registrations (hereinafter referred to as the "Registrations"), short particulars of which are set forth in Schedule A attached hereto, for Trade Marks, and is the applicant of an Application (hereinafter referred to as the "Application"), short particulars of which are set forth in Schedule B attached hereto, for Trade Marks, the Trade Marks of the Registrations and the Application are hereinafter referred to as the "Trade Marks".
- (b) By virtue of an Agreement made between the parties hereto the Assignor purported to transfer unto the Assignee all its right, title, share and interest in and to the Registrations, the Application, the Trade Marks and any registration granted pursuant thereto together with the goodwill of the business associated with and symbolised by the Registrations, the Application and the Trade Marks.

- (c) In the premises the parties hereto have agreed to execute this further Assignment to supplement, and so far as relevant to supplement the Agreement between the Assignor and the Assignee to assign and vest in the Assignee all the property, right, title, share and interest in and to the Registrations, the Application, the Trade Marks and any registration granted pursuant thereto together with the goodwill of the business associated with and symbolised by the Registrations, the Application and the Trade Marks.

NOW THIS DEED WITNESSETH that in consideration of these premises and of the sum of Ten Euro (€10.00) paid by the Assignee to the Assignor, the receipt of which the Assignor does hereby acknowledge, the Assignor hereby assigns unto the Assignee its successors and assigns:

- (a) all the property, right, title, share and interest in and to the Registrations TOGETHER with the goodwill of the business associated with and symbolised by the Registrations,
- (b) all the property, right, title, share and interest in and to the Application together with all the benefits of the Application to the intent that upon the Application being in order for registration this Assignment shall operate to vest the same in the Assignee TOGETHER with the goodwill of the business associated with and symbolised by the said Application, and
- (c) all the property, right, title, share and interest in and to the Trade Marks TOGETHER with the goodwill of the business associated with and symbolised by the Trade Marks,

TO HOLD unto the Assignee absolutely.

AND the Assignor hereby covenants with the Assignee that at the expense of the Assignee, it shall execute all such documents, forms and authorisations and depose to or swear any and all declarations or oaths as may be required for the purpose of absolutely vesting and recording the rights assigned hereunder in the Assignee.






