## TRADEMARK ASSIGNMENT

- f. This Agreement is valid, binding and enforceable in accordance with its terms; and
- g. Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.
- h. the Assignee can register and dispose of the copyright in the Work in the Assignee's own name.

### **ENTIRE AGREEMENT**
